Investment switches are processed on a forward pricing basis. This means that your switch will be processed at unit prices set **after** this application is received. Unit prices are normally set on a Tuesday. In order to receive the unit price set on a particular Tuesday, Australian Catholic Superannuation must receive this form by the close of business (5.30pm AEST or AEDST) on the Friday before.

Important: A cancellation of investment choice will be accepted up to Friday 5.30pm AEST only.
